

COPLA CAMPAIGN ACHIEVEMENTS

1. **In the 73rd United Nations General Assembly**, Mauricio Macri, **president of the Argentine Republic**, restated the need of creating a **complementary court on a region level in order to jointly face organized crime** in September, 2018.
2. **The Argentine Group of Parliamentarians for Global Action expressed its support for the creation of COPLA** for the persecution and punishment of the criminal leaders, in close collaboration with the national justice and security forces of the region in August, 2018.
3. **The Euro-Latin American Parliamentary Assembly expressed its support for the creation of COPLA as a new solution to prosecute transnational organized crime.** It was demonstrated through a message from the Copresidents of the Foreign Affairs Ministers of the European Union, CELAC and United Nations in July, 2018.
4. **A joint declaration of the Ministers of Justice, Security and Interior of MERCOSUR** in support of COPLA as a **viable initiative to fight against transnational organized crime**, in pursuit of a region free of trafficking and without organized crime in June, 2018.

 - b. **Argentine Chamber of Deputies** in 2016. Presented by Congressman Mario Negri.

6. Presentation of the campaign in the **Working Group on Security, Organised and Transnational Crime and Terrorism** during the meetings of the EuroLat standing parliamentary committees in April, 2018.
7. **Official Presentation of the initiative in the United Nations during the 16th Assembly of States Parties of the International Criminal Court** in December, 2017.
8. **Official Presentation of the Draft Statute for COPLA in the University of Buenos Aires' Law School**, with representatives of the Ministry of Foreign Affairs and Worship; Ministry of Security and Ministry of Justice and Human Rights of the Argentine Republic in November, 2017.
9. **In the 72nd United Nations General Assembly**, Gabriela Michetti restated the need for the creation and enforcement of the Latin American and Caribbean Criminal Court Against Transnational Organized Crime, in New York City in September, 2017.
10. Meeting with the **Minister of Foreign Affairs and Worship of the Argentine Republic, Jorge Faurie**, in August, 2017.
11. Meeting between **Prof. Fernando Iglesias, Director of the COPLA campaign, Mauricio Macri President of the Argentine Republic, and Horacio Rodriguez Larreta, Head of Government of the Autonomous City of Buenos Aires**, who reaffirmed their interest and support to the initiative in June, 2017.
12. COPLA has received support from:

14. COPLA's Draft Statute was included in the **program "Justicia 2020"**, launched by the Argentine Ministry of Justice and Human Rights.

15. The COPLA campaign was introduced in the **Euro-Latin American Parliamentary Assembly** chaired by Ramón Jáuregui Atondo, European Parliament in the Strasbourg headquarters in February, 2017.
16. **The Ministry of Justice and Human Rights passed a resolution** to create the “**Committee of Experts in Controlling Organized Crime and Corruption**”. In said resolution, subparagraph “d” of art. 3 is about advising COPLA, May, 2016.
17. Meeting in the **Casa Rosada with ambassadors of Latin American countries based in Argentina**, held by Gabriela **Michetti** in April, 2016.
